

**FORMAL NOTIFICATION OF CRIMINAL ACTIVITY
& ADVISORY OF IMMINENT PROCEEDINGS**

To.....[ALL IRISH AUTHORITIES – BY NAME AND POSITION].....

This Notice is hereby served upon you as; (i) as a citizen of this State and as a resident of the EU and; (ii) in your official capacity as listed above, to alert you, yet again, that a series of criminal offences have been committed – and continue to be committed – by various named ‘officers of the Court’ in collaboration with other agents and affiliates of the State in context of the issues and matters laid out in the publications listed below (flyers attached) – to include affidavits No’s 1-25 that have been lodged at the Four Courts before and since (which are available to you on request from us or from the Courts Service under co-joined Case Record No’s JR 2017/798 & 2018/432) – and that the proofs of the said criminal acts have been forwarded ‘according to the requirements of law’ to all of the respective statutory authorities and oversight bodies in this State including upon you as an elected official or office holder, but that NO proper response or action has resulted other than lies, stonewalling, misdirection, obfuscation, deceits-and-cover-ups, and suppression of the truth and facts by other devious and underhanded means; including via documentary frauds and counterfeits; by the alteration or disappearance of evidence; by persistent obstructions of our attempts to raise domestic and EU petitions; via fraudulent judgments and orders; by unlawful refusals to process valid applications to the Courts whilst advancing illegitimate others, and the repeat failures and refusals of the authorities to abide by the Rule of Law:

- *“CRIMINALITY IN THE IRISH COURTS & the Absence of the Rule of Law”*
- *“INDICTMENT & Petition for a Public Enquiry into State-sponsored Criminality in Ireland”*

In light of recent well-published attempts by one Michael MacGrath, judge of the High Court, to advance further criminal acts upon The Irish People and upon the Courts in open defiance of the law and the Constitution, in flagrant violation of Superior Court Rules, and in breach of his solemn oath of office sufficient to constitute undeniable offences as against justice as listed on pages 13-15 in the ‘CITIC’ book and pages 37, 73 & 74 of the INDICTMENT booklet; we hereby place you personally and formally ‘On Notice’ of the following:

- Our formal request for the impeachment of Michael MacGrath and his immediate suspension from all judicial duties until such impeachment process has concluded.
- That the matters referring constitute an ongoing conspiracy to cover up a murder, a solicitation to murder, of election fraud, and multiple attempts to pervert justice.
- You are hereby reminded of your obligations under *the Criminal Justice Act 2011*.
- That an Article 40.1 public hearing in this matter will be conducted by *The Peoples Tribunal of Ireland* on July 1st 2021 at the Criminal Courts of Justice in Dublin.
- That we will be relying upon this Notice and all other relevant correspondence to name you as a party to proceedings in the event that this becomes necessary.
