

Letter and NOTICE to all Irish Authorities

Please be advised that on January 11th 2017, that definitive proofs of the following crimes being committed by the persons named below were delivered as evidence into the personal possession of High Court Justice Richard Humphries and to barristers for the DPP's Office. That at a bare minimum, that it can be definitely proven that; (i) **Mayo State Prosecutor Vincent Deane**; (ii) **Garda Superintendent Joe McKenna**; and (iii) **Castlebar Courts Service Manager Peter Mooney** have engaged in a conspiracy to pervert, obstruct or interfere with justice inasmuch as it can be demonstrated that said persons had prior personal knowledge of the contents of a DAR recording which was then delivered to the defence in an altered format, with a number of those files missing. That in addition to the proven fraud and perjury committed under oath by Mssrs Mooney and McKenna (and by certain State-sponsored solicitors) that the prosecution team, headed up by Vincent Deane under the self-declared 'direct instructions' of DPP Claire Loftus, has; (a) knowingly facilitated the submission of fraudulent witness statements and perjured testimony; (b) has deliberately failed and refused to comply with a lawful Court Order; and (c) has committed said acts with 'scienter' and premeditated malice and with wilful disregard for the law, for the Constitution and for our fundamental rights – for the purposes of engineering an unjust outcome in the Courts.

That the various criminal offences of; (i) fraud; (ii) perjury; (iii) contempt of Court; and (iv) conspiracy to pervert, obstruct or interfere with justice are each serious criminal offences as laid out in the respective legislation and are therefore punishable as such, under the law. That said crimes have been brought to the explicit attention of **District Court Judge Aeneas McCarthy & High Court Justice Richard Humphries** and both have failed or refused to intervene in the proposed continuance of these crimes or otherwise act in accordance with their sworn duties to uphold the law and the Constitution and protect and vindicate the inalienable rights of the citizen. That said crimes have also been brought to the explicit attention of **DPP Claire Loftus**, and of **Chief Prosecuting Solicitor Helena Keily** who have likewise 'refused to comment' on said matters despite the overwhelming and incontrovertible evidence which is publicly available at the online links below, and that said lack of lawful response or action renders these persons actively complicit in the continuance of said crimes.

That a number of District Court Judges have likewise acted in flagrant disregard for the law, the Constitution and for Superior Court rulings by failing, refusing and/or improperly obstructing approximately 40 applications for private criminal 'common informer' summonses as against agents of the State who can be shown to be engaged in unlawful and/or criminal conduct. That said District Judges include: **Mary Devins; Kevin Kilraine; Miriam Malone; Michael Walsh; James Faughnan; Alan Mitchell; Aeneas McCarthy; Miriam Walsh; Seamus Hughes; Bryan Smyth; John Lindsay.**

That under **Section 19 of the Criminal Justice Act 2011**, and under **Section 9 of the Offences Against the State (Amendment) Act 1998** that we understand that it is a criminal offence NOT to report these offences to the authorities – which we are now doing (again) in this formal public NOTICE and as per the terms of the previous NOTICE & CONSTITUTIONAL DECLARATION (attached) as delivered to the relevant Irish authorities and endorsed '*qui tacet consentit*' by the same in August 2016.
